NOTICE OF APPLICATION FOR CONSENT TO AN ALTERATION OF ELIGIBILITY RULES

(D No. 30002 of 2000)

NOTICE is given that an application under the Workplace Relations Act 1996 for consent to an alteration of the eligibility rules of the Australian Municipal, Administrative, Clerical and Services Union has been received.

Information contained in the supporting documents to the application concerning the proposed alteration, the reason for the proposal and the effect of the proposal is as follows:

1. The particulars of the proposed rule alteration are the inclusion of a new Part XXI in sub-rule (b) of Rule 5 as follows:

"PART XXI

Employees engaged in administrative, clerical, technical, engineering, scientific, professional, supervisory, managerial and operational classes of work of the following employers:

ETSA Corporation,
ETSA Power Pty Ltd
ETSA Utilities Pty Ltd
ETSA Transmission Corporation – (Trading as ElectraNet SA)
SA Generation Corporation
Optima Energy Pty Ltd
Flinders Power Pty Ltd
Synergen Pty Ltd
Terra Gas Trader Pty Ltd

or any subsidiary or joint venture of the above employers;

or any successor, assignee or transmittee to the business or part of the business of the above employers whether immediate or not;

or any subsidiary or joint venture of any successor, assignee or transmittee to the business or part of the business of the above employers whether immediate or not;

or any employers defined in paragraph (14) of clause 23 of PART 4 STAFF in the *Electricity Corporations (Restructuring and Disposal) Act 1999* as follows:

'14 Employers are related for the purposes of this section if –

- (a) one takes over or otherwise acquires the business or part of the business of the other; or
 (b) they are related bodies corporate within the meaning of the Corporations Law; or
 (c) a series of relationships can be traced between them under paragraph (a) or (b).'

or any other employer that under contract or outsourcing arrangement undertakes works, operations, functions, or services undertaken previously by the above employers or undertaken previously by any successor, assignee or transmittee to the business or part of the business or the above employers whether immediate or not;

shall be eligible to be members of the Union."

2. The reason for the proposed alteration is that:

"The ASU Industry and Eligibility rules (the rules) provide coverage of a wide range of public sector and private sector employees. Generally (with some overlapping exceptions) the private sector rules provide a different and reduced scope of coverage of various classes and groups of employees than do the public sector rules.

When a publicly owned body such as a statutory corporation is privatised the ASU private sector rules may not technically cover all classes and groups of ASU members who transfer from public to private sector employment. This problem is about to occur in South Australia and is the subject of this proposed rules alteration.

In South Australia, two publicly owned electricity corporations have been disaggregated into seven new publicly owned bodies, which will be privatised by lease/sale arrangements during 2000. These lease/sale arrangements will mean the ASU private sector rules will technically limit coverage of long standing existing ASU members.

These two Corporations are ETSA Corporation (ETSA) and SA Generation Corporation (SAGC). Both these corporations are publicly owned Statutory Corporations established under the *Electricity Corporations Act 1994*.

The Electricity Corporations (Restructuring and Disposal) Act 1999 was assented to and proclaimed on 1 July 1999.

This Act provides for the lease/sale of publicly owned electricity generation, distribution and transmission assets/liabilities to private owners.

Before October 1998 the ASU had nearly 900 members employed between ETSA and SAGC. These members performed administrative, clerical, technical, engineering, scientific, professional, supervisory, managerial and operational classes of work.

On the 12 October 1998 ETSA and SAGC were both disaggregated by Ministerial Transfer Order by the Treasurer and seven new publicly owned businesses (the new employers) were formed.

After disaggregation the employees of ETSA and SAGC were respectively allocated to the new employers.

In August 1999 the numbers of ASU members allocated to the new employers who were previously employed either by ETSA and SAGC was as follows:

The ASU has continued to represent its members as usual after they were allocated to the new employers and will do so after privatisation.

On 11 March 1999 the ASU served a log of claims on the new employers and had a dispute found by Senior Deputy President Harrison on 27 July 1999 in matter C No 32177 of 1999.

The ASU has made application to vary the Electricity Trust of South Australia (Interim) Salaries Award 1990 to which ETSA and SAGC are respondents. This application is to include as respondents all of the above new employers. The ASU is also negotiating enterprise agreements with the new employers.

ASU public sector coverage will be affected in 2000 as privatisation is progressively implemented. The first sale/lease of ETSA Power and ETSA Utilities to private Hong Kong interests for 3.5 billion dollars was announced in the press on 13 December 1999.

The effect privatisation of the South Australian electricity industry will have on ASU rules is analogous to the effect privatisation of electrical power in Victoria in 1993 had on ASU rules.

In 1993 the State Electricity Commission of Victoria (SECV) was disaggregated, corporatised and the component parts sold into private ownership.

The ASU sought and gained several rule changes within the privatised Victorian Electricity Industry, which allowed coverage of former SECV, employees allocated to work for new private owners and/or any subsequent successor bodies to those new private owners.

These rule changes are now reflected in PART XVIII, PART XIX AND PART XX of sub rule b *Eligibility For Membership* of rule 5.

The decisions and orders of the Commission effecting rule changes in the Victorian Power Industry follow:

The classes and groups for which the ASU seeks private sector coverage (to the extent which it does not have that coverage) are presently ASU members. There is no other union that these classes and groups can more conveniently belong to or be more conveniently represented by. There is no other union with the eligibility rules to comprehensively cover the classes and groups presently covered by the ASU."

3. The effect of the proposed alteration is it will make the above mentioned classes of employees of the above named employers and other employers in categories described or defined above eligible for membership of the ASU to the extent that the ASU does not have that coverage.

DETERMINATION UNDER PARAGRAPH 15(1)(d) No. 1 of 2000

I, RICHARD KENNETH ROBERT ALSTON, Minister for Communications, Information Technology and the Arts, under paragraph 15(1)(d) of the *Telecommunications (Carrier Licence Charges) Act 1997*, determine that the estimated total amount of grants likely to be made during the 1999-2000 financial year under section 593 of the *Telecommunications Act 1997* is \$838,302.

EXPLANATORY STATEMENT***Telecommunications (Carrier Licence Charges) Act 1997*****DETERMINATION UNDER PARAGRAPH 15(1)(d) No. 1 of 2000****Issued by the authority of the Minister for Communications,
Information Technology and the Arts**

The *Telecommunications (Carrier Licence Charges) Act 1997* (the Act) sets out the method of calculating annual charges that apply to the carrier licences held by the telecommunications carriers. Subsection 15(1) of the Act provides that the total of the annual charges that are imposed on carrier licences in force at the beginning of the year must not exceed the sum of:

- (a) the amount determined, by a written instrument made by the Australian Communications Authority (ACA), to be the proportion of the ACA's costs for the immediately preceding financial year that is attributable to the ACA's telecommunications functions and powers; and
- (b) the amount determined, by a written instrument made by the Australian Competition and Consumer Commission (ACCC), to be the proportion of the ACCC's costs for the immediately preceding financial year that is attributable to the ACCC's telecommunications functions and powers; and
- (c) the amount determined, by a written instrument made by the ACA, to be the proportion of the Commonwealth's contribution to the budget of the International Telecommunication Union for the calendar year in which the beginning of the financial year occurs that is to be recovered from carriers; and
- (d) the amount determined, in a written instrument made by the Minister, to be the estimated total amount of grants likely to be made during the financial year under section 593 of the *Telecommunications Act 1997* (discussed below); and
- (e) the amount determined, by a written instrument made by the Minister, to be the proportion of the Commonwealth's costs for the immediately preceding financial year that is attributable to the administration of Part 2 of Schedule 1 to the *Telecommunications Act 1997* (which deals with industry development plans).

Section 593 of the *Telecommunications Act 1997* provides that the Minister may, on behalf of the Commonwealth, make a grant of financial assistance to a consumer body for purposes in connection with the representation of interests of consumers in relation to telecommunications issues. The Minister may also make a grant of financial assistance to a person or body for purposes in connection with research into the social, economic, environmental or technological implications of development relating to telecommunications.

The accompanying determination has been made for the purposes of paragraph 15(1)(d) of the Act. The determination provides that \$838,302 is the amount estimated to be the amount of grants likely to be made during the 1999-2000 financial year under section 593 of the *Telecommunications Act 1997*.

Subsection 15(2) of the Act provides that an instrument under subsection (1) must be notified in the *Gazette* before the day on which the charges referred to in subsection (1) become due for payment. The ABA is required to renew these licences unless it decides that an applicant is no longer a suitable licensee. A company is a suitable licensee if the ABA does not decide that sub-section 41(2) (for commercial) or 83(2) (for community) of the Act applies to the company.

The ABA may decide that either section 41(2) or 83(2) of the Act applies to a licensee if it is satisfied that allowing the licensee to provide or continue to provide either a commercial or a community broadcasting service under a licence would lead to a significant risk of:

- (c) an offence against the Act or the regulations being committed; or
- (d) a breach of the conditions of the licence occurring.

In deciding whether these sub-sections apply, the ABA is required by sections 41(3) (commercial) and 83(3) (community) of the Act, to take into account:

- (f) the business record of the company; and
- (g) the company's record in situations requiring trust and candour; and
- (h) (commercial) the business record of each person who is, or would be, if a licence were allocated to the applicant, in a position to control the licence; or (community) the business record of the chief executive and each director and secretary of the applicant; and
- (i) the record in situations requiring trust and candour of each such person; and
- (j) whether the company, or a person referred to in paragraph (c) or (d), has been convicted of an offence against this Act or the regulations.



- (a) if deferred benefits become payable in respect of the person - after the date of the commencement of this determination; or
- (b) if:
 - (i) deferred benefits cease to be applicable in respect of the person; or
 - (ii) in the case of a person to whom deferred benefits are not applicable - the person ceases to be an eligible employee;

on or after that date.

- (2) An expression used in subclause 5(1) that is defined in the Principal Determination has the same meaning for the purposes of that subclause as it has in that determination.





EXPLANATORY STATEMENT

ISSUED BY THE AUTHORITY OF THE MINISTER FOR HEALTH AND AGED CARE

HEALTH INSURANCE ACT 1973

DECLARATION OF QUALITY ASSURANCE ACTIVITIES UNDER SECTION 124X

QAA No. 1/2000

Part VC of the *Health Insurance Act 1973* (the Act) creates a scheme to encourage efficient quality assurance activities. Those activities help to ensure the quality of health services that are funded by the government, for example, through Medicare benefits. The scheme encourages participation in such activities by protecting certain information from disclosure, and also by protecting the persons engaged in those activities, in good faith, from civil liability in respect of those activities. In order for Part VC to apply to an activity, the Minister must make a Declaration.

This Declaration applies Part VC to the Royal Australasian College of Physicians (RACP) Maintenance of Professional Standards Program (MOPS) (Item 1) and the Australia and New Zealand College of Anaesthetists (ANZCA) Maintenance of Professional Standards Program (MOPS)(Item 2) (the Activities).

The Declaration is a disallowable instrument for the purposes of section 46A of the *Acts Interpretation Act 1901*.

The Activities relate to the quality of health services that would be eligible for payment in respect of Medicare Benefits (Items 1 and 2), Health Program Grants (Item 2) and supply of pharmaceutical benefits (Item 2).

The Activity at Item 1 of the Schedule has the purpose of ensuring the active participation of physicians in continuing education and evaluation of the quality of their practices. The Activity at Item 2 of the Schedule has the purpose of ensuring the involvement of anaesthetists in a range of ongoing educational activities in order to provide the highest quality of patient care.

Before the Minister can make a declaration, certain requirements must be met.

Firstly, the persons engaged in the activities must be authorised to do so. The authorisation can be by an association of health professionals, by a body that provides health care, by an educational institution or by a body established for the purposes of research. The persons engaged in the Activity under Item 1 of the Schedule are authorised to do so by the Royal Australasian College of Physicians which is an association of health care professionals. The persons engaged in the Activity under Item 2 of the Schedule are authorised to do so by the Australian and New Zealand College of Anaesthetists which is an association of health care professionals.

Secondly, the Minister has to be satisfied that it is in the public interest to have Part VC of the Act apply to the activities. The Minister must have regard to criteria prescribed by the regulations. The criteria relevant to the Activities are in regulations 23C and 23F of the Health Insurance Regulations. The Activities meet those criteria as follows:

- as required by Regulation 23C, the Activities include the disclosure of non-identifying information that concerns the quality of service assessed, evaluated or studied or the factors affecting the quality of the service, and satisfy the requirement that information is provided at times and in a manner acceptable to the Minister. In the Activity under Item 1 of the Schedule the persons engaged in the Activity will provide non-identifying information regarding participation and compliance under the MOPS program as part of RACP's general reporting activities to its Fellows. Copies of this information will be provided to the Minister for Health and Aged Care. In the Activity under Item 2 of the Schedule the persons engaged in the Activity will provide non-identifying information regarding participation and compliance under the MOPS program as part of ANZCA's general reporting activities to its Fellows. Copies of this information will be provided to the Minister for Health and Aged Care.



5. No other changes have been made to the product.

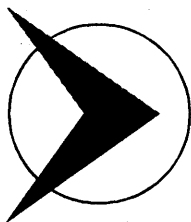



CONTINUATION INQUIRY:

BULK BRANDY FROM FRANCE

The Australian Customs Service has completed its inquiry into whether countervailing measures currently applying to imports of bulk brandy (of alcoholic strength by volume exceeding 57%) from France should be continued for a further five years. The findings of Customs are detailed in Trade Measures Report no. 14.

Customs is satisfied that subsidies are still payable by the European Commission on bulk brandy produced in France and that the subsidies are likely to continue for the foreseeable future.

Customs is also satisfied that the expiration of the countervailing duty would be likely to lead to a continuation of the subsidisation and the material injury that the duty was intended to prevent.

In the light of the above, Customs has recommended that the Minister take action to continue the countervailing duty for a further five years.

The Minister for Justice and Customs has accepted Customs recommendation and, as a consequence, the countervailing measures will continue until 27 February 2005.
