NOTICE OF APPLICATION FOR CONSENT TO AN ALTERATION OF ELIGIBILITY RULES

(D No 20004 of 2000)

NOTICE is given that an application under the Workplace Relations Act 1996 for consent to an alteration of the eligibility rules of the CPSU, the Community and Public Sector Union has been received.

1. The particulars of the proposed rule alterations are as follows:

(I) the inclusion in Chapter A of a new sub-paragraph (c) in paragraph (G) of Rule 2, Part II, Section I as follows:

"(c) Notwithstanding anything contained in this rule and for the purpose of giving effect to the Private Correctional Facilities (LHMU/CPSU) Demarcation Order 1998 recorded in Print P9108, persons employed by operators of the correctional facilities or prison transport activities named below or by any successor in business (or part of the business or undertaking) concerned in the correctional facilities or the prisoner transport activities named below:

- (i) Fulham Correctional Centre in Sale;
- (ii) Port Phillip Correctional Centre;
- (iii) Deer Park Correctional Centre;
- (iv) Corrections Corporation of Australia Pty Ltd ACN 010 291 641 in the activity of providing security escort services for the transport of prisoners including transport to and from correctional facilities, courts and hospitals in Victoria.

Provided that nothing in this sub-paragraph will render the following persons eligible for membership of the union:

Managers, teachers, nurses and persons employed in administrative and clerical positions by the operators of these correctional facilities or prisoner transport activities including those who may become eligible solely as a result of the Private Correctional Facilities (LHMWU/CPSU) Demarcation Order 1998 [Print P9108]; or

Persons employed by Group 4 Correction Services Pty Ltd ACN 050 069 255 in Victoria in the activity of providing security escort services for the transport of prisoners including transport to and from correctional facilities, courts and hospitals."

- (II) the inclusion in Chapter A of a new sub-sub-paragraph (c) in sub-paragraph (4) in paragraph (B) of Rule 3, Part II, Section I as follows:

"(c) Notwithstanding anything contained in this rule and for the purpose of giving effect to the Private Correctional Facilities (LHMU/CPSU) Demarcation Order 1998 recorded in Print P9108, persons employed by operators of the correctional facilities or prison transport activities named below or by any successor in business (or part of the business or undertaking) concerned in the correctional facilities or the prisoner transport activities named below:

- (i) Fulham Correctional Centre in Sale;
- (ii) Port Phillip Correctional Centre;
- (iii) Deer Park Correctional Centre;
- (iv) Corrections Corporation of Australia Pty Ltd ACN 010 291 641 in the activity of providing security escort services for the transport of prisoners including transport to and from correctional facilities, courts and hospitals in Victoria.

Provided that nothing in this sub-sub-paragraph will render the following persons eligible for membership of the union:

Managers, teachers, nurses and persons employed in administrative and clerical positions by the operators of these correctional facilities or prisoner transport activities including those who may become eligible solely as a result of the Private Correctional Facilities (LHMU/CPSU) Demarcation Order 1998 [Print P9108]; or

Persons employed by Group 4 Correction Services Pty Ltd ACN 050 069 255 in Victoria in the activity of providing security escort services for the transport of prisoners including transport to and from correctional facilities, courts and hospitals."

2. The reason for the proposed alterations is to give effect to the Private Correctional Facilities (LHMU/CPSU) Demarcation Order 1998 [Print P9108].
3. TOBACCO ADVERTISING PROHIBITION ACT 1992

SPECIFICATION UNDER SUBSECTION 18(2)

I, Michael Wooldridge, Minister for Health and Aged Care, under subsection 18(2) of the *Tobacco Advertising Prohibition Act 1992* (the Act), having regard to the guidelines in force under subsection 18(5) of the Act and being satisfied that the event mentioned below is of international significance and that failure to specify the event would be likely to result in the event not being held in Australia, HEREBY:

- (a) specify the 2001 Qantas Australian Grand Prix to be held at Albert Park in Melbourne on or about 1 - 4 March 2001, or such other dates as are specified in the Federation Internationale de l'Automobile (FIA) 2001 Formula One Calendar, as a sporting event to be held in Australia; and
- (b) specify, under subsection 18(3), the following as conditions to be complied with in relation to the publication of tobacco advertisements in connection with the event:
 - i. the number of tobacco advertisements that may be published is limited to:
 - A. the advertisements required by, or otherwise pursuant to, international contracts or arrangements for the sponsorship of individual teams and drivers, being contracts or arrangements in place at the commencement of the 2001 Formula One season but excluding advertisements displayed in the official program and on uniforms of promotional personnel, simulators, displays and giveaways; and
 - with respect to team personnel, the ability to display tobacco advertisements shall be limited to those personnel with access to the area known as the Formula One paddock.
 - B. 20 Marlboro signs (2m x 10m), one double sided Marlboro bridge sign (2m x 20m), and 5 Marlboro hangover signs (1m x 5m);
 - C. advertisements contained on merchandise produced in accordance with the requirements of or pursuant to international contracts or arrangements for the sponsorship of teams and drivers provided that all such merchandise includes the name of the Formula One Constructor; and
 - any wording on merchandise that can be construed as a tobacco advertisement shall occupy the same space and be in type no larger than the name of the constructor; and
 - there will be no tobacco advertising (other than that contained on the merchandising items) permitted at the retail outlets selling team/driver merchandise.



- D. tobacco advertisements displayed on exhibits (including no more than 8 tobacco sponsored cars) at the proposed Formula One Exhibition and on merchandise at retail outlets provided that health warnings as set out in Column 2 of Schedule 1 of the Trade Practices (Consumer Product Information Standards) (Tobacco) Regulations are prominently displayed:
- at the entry and exit to the proposed Formula One Exhibition and within each of the tobacco-sponsored team-based exhibits; and
 - at each of the retail outlets selling merchandise carrying tobacco advertisements.
- Each health warning must comply with the format set out in regulation 9 of the Regulations.
- ii. in addition to the above mentioned clauses, the content of the advertisements that may be published is limited to:
- A. the content of the advertisements required by, or otherwise pursuant to, international contracts or arrangements for the sponsorship of individual teams and drivers, being contracts and arrangements in force at the commencement of the 2000 Formula One season; and
 - B. all signs referred to in paragraphs (b) (i) (B) above must include one of the health warnings set out in Column 2 of Schedule 1 of the Trade Practices (Consumer Product Information Standards) (Tobacco) Regulations. Each of the health warnings set out in Column 2 of Schedule 1 shall appear as nearly as possible on an equal number of signs. Each health warning must comply with the format set out in regulation 9 of the Regulations, must occupy at least 25% of the total area of each sign and must be located so there is no impairment of their visibility. This may require placement of the health warning at the top of the sign.
- iii. the way in which the advertisements may be published is limited to the advertisements, including promotional activities, being confined to the venue of the Event, namely Albert Park, Victoria.

This specification comes into force on the date being six calendar days before the first day of the event as specified in the FIA calendar and ends on the date being three days after the last day of the event as specified in the FIA calendar.

TOBACCO ADVERTISING PROHIBITION ACT 1992

NOTICE UNDER SUBSECTION 18(2)

I, Michael Wooldridge, Minister for Health and Aged Care, under subsection 18(2) of the *Tobacco Advertising Prohibition Act 1992* (the Act), having regard to the guidelines in force under subsection 18(5) of the Act, and being satisfied that the event mentioned below is of international significance and that failure to specify the event would be likely to result in the event not being held in Australia:


1. specify the 2000 Rally Australia (the Event) to be held in Western Australia, from 9-12 November 2000 as a sporting event to be held in Australia; and
2. specify, under subsection 18(3), the following conditions as conditions to be complied with in relation to the publication of tobacco advertisements in connection with the event:
 - a) the number of tobacco advertisements that may be published is limited to advertisements displayed on motor vehicles participating in the event and on the uniforms of competing drivers and co-drivers where these are required by, or otherwise pursuant to, international contracts or arrangements for the sponsorship of individual teams or drivers, being contracts or arrangements for drivers or teams that have competed in at least five previous rounds of the 2000 World Rally Championship in the previous twelve months;
 - b) the drivers (and their respective co-drivers) must be nominated to score points by teams registered for the 2000 FIA World Rally Championship, 2000 FIA Teams Cup in the previous twelve months, or have contested at least five rounds of the FIA World Rally Championship in the previous twelve months; and
 - c) in addition to the above mentioned clauses, the content of the advertisements that may be published is limited to the following:
 - (i) the content of the advertisements required by or otherwise pursuant to, international contracts or arrangements for the sponsorship of individual teams or drivers, being contracts or arrangements for drivers or teams that have competed in at least five previous rounds of the 2000 World Rally Championship in the previous twelve months;
 - (ii) all tobacco advertisements referred to in paragraph 2.(a) above must be accompanied by the words 'SMOKING KILLS' ("the health warning");
 - (iii) each health warning must comply with the format set out in regulation 9 of the *Trade Practices (Consumer Product Information Standards) (Tobacco) Regulations* ("the Regulations"), with the following modifications:
 - in paragraph 9(a)(i) of the Regulations the word "black" is substituted with the word "white";
 - in paragraph 9(a)(ii) of the Regulations the word "white" is substituted with the word "black"; and
 - in paragraph 9(b)(iii) of the Regulations the word "black" is substituted with the word "white";
 - (iv) each health warning must occupy at least 50% of the area devoted to the display of the tobacco advertisement; and



- (v) advertising displayed on a motor vehicle, driven for the purposes of competing in the 2000 Rally Australia event, is limited to the external surfaces of the motor vehicle, when its doors, windows, bonnet and boot are closed.
 - d) the way the advertisements may be published is limited to the way described in paragraph 2.(a) above, provided that advertisements are only visible while the Event is in progress, during official events listed in the 2000 Telstra Rally Australia Program, in official testing or Shakedown for the Event (on condition that these are events listed in the official 2000 Telstra Rally Australia Program), and while the vehicles are being driven directly to and from those events.
 - e) the event organiser, the Western Australian Tourism Commission, is required to formally advise teams of the need to comply with the conditions set out in this notice.
3. for the avoidance of doubt the following items are specifically excluded from the terms of this notice:
- advertisements on the uniforms of support staff and persons officially supporting or directly assisting competitors at the event;
 - advertisements on official vehicles used for the transport of competitors, support staff and persons officially supporting or directly assisting competitors at the event;
 - advertisements on mannequins or other objects; and
 - use of illuminated tobacco advertising or health warning signage.

This specification comes into force on 1 November 2000 and remains in force up to and including 12 November 2000.
