The Repatriation Medical Authority (the Authority) gives notice under section 196G of the *Veterans' Entitlements Act 1986* (the Act) that it intends to carry out an investigation under section 196B(7) of the Act to review the contents of Statements of Principles concerning multiple sclerosis (Instrument Nos.170 and 171 of 1995).

The Authority invites the following persons and organisations to make written submissions to the Authority in respect of the investigation:

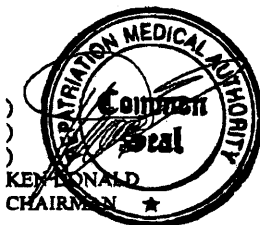
- any person eligible to make a claim for pension under Part II or Part IV of the *Veterans' Entitlements Act 1986*;
- any organisation representing veterans, Australian mariners, members of the Forces, members of the Peacekeeping Forces or their dependants;
- the Repatriation Commission; and
- any person having expertise in a field relevant to the investigation.

The Authority will hold its first meeting for the purposes of this investigation on **6 March 2001**.

Under the Act, the Authority is required to find out whether there is new information available about how multiple sclerosis may be contracted or death from multiple sclerosis may occur; or the extent to which multiple sclerosis or death from multiple sclerosis may be war-caused or defence-caused. 



1. Harvesting is limited to road alignment areas on the South Face Road and minor roads within the Erica District, Central Gippsland.
2. Harvesting is to be conducted in accordance with harvest proposals submitted by Fernworld in August 2000 and as set out in permits issued by the Victorian Department of Natural Resources and Environment.
3. All *Dicksonia antarctica* trunks/plants over 15cm in height are to be tagged and the tag numbers of those proposed for export are to be specified in the applications for permits to export.
4. For *Dicksonia antarctica*, the Victorian Department of Natural Resources and Environment is to provide the Designated Authority with tag numbers issued, the number of trunks/plants under 15cm high harvested and the quantity of 'dead' stems harvested for use as manufactured by-products such as pots and slabs.
5. A report on the total numbers harvested under this permit, by species and for *Dicksonia antarctica* by category (over 15cm, under 15cm and 'dead' stems) detailing both domestic and export quantities, is to be provided to the Designated Authority.
6. This declaration is valid until 30 June 2001, or until approval of a State wide management plan for the relevant species.
