DETERMINATION 2001

I, Ian Gordon Campbell, Minister for the Environment and Heritage, provide the following information concerning my decision to grant approvals under section 13 of the Fuel Quality Standards Act 2000 (the FQS Act).

#### Name of approval holders

Approvals have been granted to BP Australia Pty Ltd, The Shell Company of Australia, Caltex Australia Petroleum Pty Ltd and Mobil Oil Australia Pty Ltd.

#### Period of operation

The period of operation of the approvals is from the date of the approvals until 31 December 2005.

#### Details of the Approval

In respect of automotive diesel supplied by the approval holders or the 'regulated persons' listed at **Annexure 1** of each approval, this approval varies the *Fuel Standard (Automotive Diesel) Determination 2001* so that diesel with the following parameters:

(i)	Viscosity	1.2c St @ 40°
(ii)	Density	800 kg/m3
(iii)	Lubricity	0.700 mm
(iv)	Sulfur	1000 ppm

complies with the viscosity, density, lubricity and sulfur specifications for diesel fuel in the Determination, subject to the conditions listed in the approval at **Annexure 2**.

A copy of each approval is attached to this Notice.

#### Background

Fuel standards for automotive diesel are contained in the Fuel Standard (Automotive Diesel) Determination 2001 (the Determination). Some areas of Australia, such as alpine regions, experience extremely cold conditions, typically from May to September. Under these cold conditions, automotive diesel that complies with the Determination is prone to 'waxing' (ie. wax molecules crystallise). This may result in solidifying in the fuel lines, filters and strainers in diesel powered engines and machinery causing blockages, resulting in the engine becoming either difficult or impossible to start.

The petroleum industry has recognised this situation for many years and has supplied, without adverse effects, 'wintermix diesel'. Wintermix is automotive diesel that has been blended with heating oil at varying percentages. Whilst the supply of wintermix results in a fuel that does not suffer from 'waxing', it also results in altering the following parameters so that they do not meet the standards prescribed in the Determination: viscosity; density; lubricity; and sulfur.

BP Australia Pty Ltd, The Shell Company of Australia, Caltex Australia Petroleum Pty Ltd and Mobil Oil Australia Pty Ltd have requested a variation based on the most 'extreme' standard (ie. the highest or lowest requested) where 100% heating oil would be supplied. This would only occur at high altitude areas during the winter months – the majority of wintermix will be blended at lower levels (eg. 10-30% blends).

#### Findings on material questions of fact

#### (a) Protection of the environment

It is not expected that the supply of either wintermix blends, or 100% heating oil will impact adversely on the environment. The quantity of these fuels supplied, when compared with regular diesel, is small. The fuel parameters affected are viscosity, density, lubricity and sulfur.

Viscocity is important for the operation of fuel injection equipment that is required to accurately measure small quantities of fuel prior in injection and to atomise the fuel in the injection process. Fuel with too low a viscosity can result in excessive wear in some injection pumps and in power loss due to pump injector leakage. Spray may not atomise sufficiently, therefore combustion is impaired and power output and fuel economy are decreased. This can have an adverse effect on emissions performance. The decrease in viscosity that the applicant is seeking is marginal for the majority of blends.

Density relates to the energy content of fuel in such a way that the higher the density of the fuel the higher its energy content per unit volume. Diesel fuel is injection is calibrated and metered volumetrically, although the engine delivery is a function of the mass of fuel injected. Variations in fuel density (and viscosity) will therefore affect engine power and consequently fuel consumption. The maximum reduction in density of 0.02 below the minimum specified is equivalent to a reduction in nett energy content of 0.70 Mj/l or 1.9%. This will be compensated by increased thermal efficiency while operating at low temperatures.

Lubricity is specified for long term protection of fuel pumps and injection systems. The applicants have requested an increase in the maximum wear scar diameter in the High Frequency Reciprocating Rig Test to equate for a reduction in lubricity. The reduction of lubricity is minimal and will not cause problems with diesel fuel pumps.

Sulfur occurs naturally in crude oil and the sulfur content of diesel fuel depends on both the source of the crude oil and the refining process. The contribution of the sulfur content of diesel fuel to exhaust particulate emissions is well established with a general linear relationship between fuel sulfur levels and emissions. Sulfur is known to have effects on engine wear and deposits, but appears to vary considerably in importance, depending largely on operating conditions. High sulfur content becomes a problem in diesel engines operating at low temperatures, or intermittently. Under these conditions there is more moisture condensation, which combines with sulfur compounds to form acids and results in corrosion and excessive engine wear.

An increase in the sulfur parameter will result in an increase in particulates that are significant for urban air quality. As the users of wintermix are located in rural areas, the impact of particulates on the urban environment will not be significant.

(b) Protection of occupational and public health and safety

The supply of wintermix will ensure that diesel engines and machinery will function effectively under cold conditions.

(c) Interests of consumers

Consumers in colder areas of Australia where the waxing of diesel fuel is problematic, would be disadvantaged if diesel fuel that was fit for purpose (ie. wintermix or 100% heating oil) was not supplied to their regions. The failure to supply wintermix may result in diesel engines and machinery either failing to operate, or operating inefficiently.

(d) Impact on economic and regional development

The failure to supply wintermix may result in diesel engines and machinery either failing to operate, or operating inefficiently. This may result in either impeding, or adversely affecting economic development. Wintermix is supplied to cold regions of Australia, which are predominately rural areas.

#### Reasons for decision

- 1. The supply of wintermix constitutes, overall, a small amount of the total diesel fuel supplied within Australia.
- 2. The supply of wintermix provides a fuel that is fit for purpose in cold regions of Australia, which ensures that diesel engines and machinery will operate without the fuel being prone to 'waxing'.
- 3. Wintermix will only be supplied from the date of the approval until 31 October 2005 to areas where cold weather conditions occur.
- 4. The approval holders are required to report to the Department of the Environment and Heritage on the amount of wintermix supplied.

5. The approval is valid for a limited time from the date of the approval until 31 December 2005.

## This approval is subject to the following conditions:

- 1. Wintermix diesel will only be supplied between the date of the approval and 31 October 2005.
- 2. Wintermix diesel will be blended only at terminals and depots that are licensed to do so under the *Excise Act 1901*.
- 3. Standard Wintermix comprises automotive diesel fuel and light heating oil in ratios of 80:20 or 60:40. The approval holders will undertake to supply Wintermix with specifications for viscosity, density, sulfur and lubricity as close to the Diesel Determination as is feasible. Specifically, the approval holder will strongly endeavour to meet the Truck Industry Council requirements for viscosity of a minimum of 1.4cSt and lubricity of 620 mm maximum.



Australia's Gene Technology Regulator is responsible for administering the national regulatory system designed to protect the health and safety of people and the environment by identifying risks posed by, or as a result of, gene technology and managing those risks.

The Regulator is currently assessing licence application DIR055/2004 for a limited and controlled release of genetically modified (GM) cottons from Monsanto Australia Limited:

⇒ The application proposes a large scale field trial of herbicide tolerant and herbicide tolerant/insect resistant GM cottons on up to 91 sites covering a total area of 1811 hectares over two planting seasons between September 2005 and November 2006. Summer plantings would take place on up to 1769 hectares on 86 sites in NSW and southern Qld and winter plantings would be on up to 42 hectares on 5 sites in northern WA, NT and northern Qld. The purpose of the trial is to introduce the herbicide tolerance trait into elite Australian varieties and would include testing agronomic performance, seed increase and establishing demonstration sites.

The Regulator has prepared a risk assessment and risk management plan (RARMP) for the proposed release including a range of proposed licence conditions (including containment measures) that would be imposed if a licence was issued.

The Regulator invites written submissions on the RARMP in order to finalise the plan. This document will then form the basis of the Regulator's decision whether to issue the licence. ## ADDITIONAL PROVISION (S303FT)

Relating to the harvesting of beach-washed bull kelp (Durvillaea potatorum), harvested from specified beaches of King Island, Tasmania by a number of licensed harvesters under the Tasmanian Living Marine Resources Management Act 1995 and processed by Kelp Industries Pty Ltd.

- 1. Harvesting of beach-cast Durvillaea potatorum is restricted to:
  - a. the west coast of King Island between Cape Wickham and approximately five kilometres due south of Ettrick Beach;
  - b. the south coast of King Island from Surprise Bay to the east of Stokes Point; and
  - c. the south-east coast of King Island from three areas around Red Hut Point, Grassy Harbour and City of Melbourne Bay.
- 2. Harvesting is to be in accordance with conditions stipulated on relevant licences issued by the Tasmanian Department of Primary Industries, Water and Environment (TDPIWE).
- 3. The harvest is restricted to a maximum of 50% of available beach-washed material at each harvesting site.
- 4. Harvesting and transporting of kelp and/or equipment is prohibited from August to March (inclusive) on sandy beaches, except the north-end of British Admiral Beach and any other sandy beach for which a representative from TDPIWE has verified in writing that harvesting would not be detrimental to nesting *Thinornis rubricollis* (hooded plovers).
- 5. Recording of monthly harvest figures is to be undertaken as specified by the Secretary of the Department of the Environment and Heritage.
- 6. A quarterly report on the monthly harvest figures to be submitted to the Secretary within one month of the end of each quarter.

## The designated EFTPOS system

This notice is published in accordance with the requirements set out in Section 28 (2) of the Payment Systems (Regulation) Act 1998 (the Act).

The Reserve Bank of Australia proposes to determine in accordance with Section 18 of the Act the following standard to be complied with by the participants in the designated EFTPOS payment system:

Standard No. 3 entitled The Setting of Interchange Fees in the EFTPOS Payment System.

## Summary of purpose and effect of proposed Standard No. 3

The purpose of Standard No. 3 is to ensure that the setting of interchange fees in the EFTPOS payment system promotes efficiency and competition in the Australian payments system. The Standard requires that interchange fees in the EFTPOS payment system paid by issuers to acquirers be set in accordance with an objective benchmark that would be recalculated every three years. The effect of the standard is expected to be a reduction in the average interchange fee paid by issuers to acquirers from around 20 cents to around 5 cents.

Together with proposed Standard No. 4, the proposed Standard is expected to encourage price signals and behaviour that will, over time, promote the development of a more efficient payments system in Australia.

## Standard No. 3

## The Setting of Interchange Fees in the EFTPOS Payment System

## Objective

The objective of this Standard is to ensure that the setting of interchange fees in the designated EFTPOS payment system promotes:

- (i) efficiency; and
- (ii) competition

in the Australian payments system.

## **Application**

- 1. This Standard is determined under Section 18 of the *Payment Systems (Regulation)*Act 1998.
- 2. This Standard applies to the payment system operated within Australia known as the EFTPOS system, which was designated as a payment system on 9 September 2004 and referred to below as the EFTPOS system.
- 3. In this Standard:

an 'acquirer' is a participant in the EFTPOS system that provides services to a merchant to allow that merchant to accept a debit card;

'cash out' means the provision of cash to a cardholder by a merchant, as a result of a debit card transaction at the merchant;

'debit card' means a card issued by a participant in the EFTPOS system that allows the cardholder to make payments to merchants for goods and services or obtain cash out using the EFTPOS system by accessing a deposit account held at the participant;

'debit card transaction' or 'transaction' means a transaction in Australia between a debit cardholder and a merchant involving the purchase of goods and services and/or the provision of cash out using a debit card;

'financial year' is the 12-month period ending 30 June;

an 'issuer' is a participant in the EFTPOS system that issues debit cards to its customers;

'merchant' means a merchant in Australia that accepts a debit card for payment of goods and services and/or that provides cash out;

a 'merchant principal' is a participant in the EFTPOS system that is a merchant that sends transactions directly to issuers rather than through an acquirer and takes on the responsibilities usually undertaken by an acquirer;

'nominated EFTPOS acquirers' are those acquirers and merchant principals determined by the Reserve Bank, selected in order of their share of the number of transactions, who comprise the minimum number of such acquirers or merchant principals required to account for at least 90 per cent of the number of transactions acquired in the EFTPOS system in the 'reference year';

'reference year' is the financial year prior to the relevant year;

'relevant year' is the financial year in which the benchmark is calculated;

terms defined in the *Payment Systems (Regulation) Act* 1998 have the same meaning in this Standard.

- 4. This Standard refers to wholesale fees, known as 'interchange' fees, which are payable between an issuer and an acquirer or merchant principal, directly or indirectly, in relation to a debit card transaction in the EFTPOS system.
- 5. Each participant in the EFTPOS system must do all things necessary on its part to ensure compliance with this Standard.
- 6. If any part of this Standard is invalid, the Standard is ineffective only to the extent of such part without invalidating the remaining parts of this Standard.
- 7. This Standard is to be interpreted:
  - in accordance with its objective; and
  - by looking beyond form to substance.
- 8. This Standard comes into force on [1 July 2006].

## **Interchange Fees**

9. Issuers and acquirers or merchant principals in the EFTPOS system may agree to pay an interchange fee between themselves. If such a fee is paid by an issuer, the total fee for each transaction must not exceed the benchmark published by the Reserve Bank in accordance with paragraph 15.

## Methodology

- 10. The benchmark for the EFTPOS system is calculated by the Reserve Bank as follows:
  - a. for each of the nominated EFTPOS acquirers, the aggregate value of eligible costs in the reference year is to be divided by the number of debit card transactions in the reference year. This ratio is to be expressed as a number of cents per transaction;

- b. the benchmark is to be calculated by the Reserve Bank as the aggregate value of eligible costs in the reference year of the three nominated EFTPOS acquirers with the lowest ratios as calculated in 10a, divided by the number of transactions undertaken by the same three nominated EFTPOS acquirers in the reference year. The result is to be expressed as a number of cents per transaction, rounded to the nearest cent.
- 11. Eligible costs are those directly related to processing and switching EFTPOS transactions incurred by an acquirer or merchant principal when performing the business responsibilities usually undertaken by an acquirer.
- 12. Data on eligible costs must be drawn from accounting records of the nominated EFTPOS acquirers, prepared in accordance with generally accepted accounting principles and Australian accounting standards.
- 13. Data on eligible costs must be provided by each nominated EFTPOS acquirer to the Reserve Bank of Australia, or its agent, by [15 August] in the relevant year.
- 14. The Reserve Bank, or its agent, will review the data to determine if the costs included are eligible costs and the Reserve Bank will use the eligible costs to calculate the benchmark in accordance with paragraph 10.
- 15. The Reserve Bank will publish the benchmark for the EFTPOS system by [15 September] in the relevant year.
- 16. Interchange fees in the EFTPOS system must conform with the benchmark from [31 October] in the relevant year.

## Initial and subsequent benchmarks

- 17. For the initial benchmark the relevant year is the financial year [2006/07].
- 18. The benchmark is to be recalculated in the financial year [2009/10] and every three years thereafter.

## Transparency

- 19. Acquirers and merchant principals in the EFTPOS system must report to the Reserve Bank the weighted average interchange fee they received and the range of interchange fees received in the previous financial year by [30 September] each year. The weights to be used in this calculation are shares of transaction value to which each interchange fee applies. In the first year, this requirement applies to the [8] months ending [June 2007].
- 20. The Reserve Bank will publish the industry weighted average of interchange fees on its website.

The Reserve Bank of Australia proposes to determine in accordance with Section 18 of the Act the following standard to be complied with by the participants in the designated Visa Debit system:

Standard No. 4 entitled The Setting of Interchange Fees in the Visa Debit Payment System.

## Summary of purpose and effect of proposed Standard No. 4

The purpose of proposed Standard No. 4 is to ensure that the setting of interchange fees in the Visa Debit payment system promotes efficiency and competition in the Australian payments system. The Standard requires that interchange fees in the Visa Debit system paid by acquirers to issuers be set in accordance with an objective benchmark that will be recalculated every three years. The effect of the Standard is expected to be a reduction in the average interchange fee in the Visa Debit system from around 40 cents per transaction to around 15 cents.

Together with proposed Standard No. 3, the proposed Standard is expected to encourage price signals and behaviour that will, over time, promote the development of a more efficient payments system in Australia.

## Standard No. 4

## The Setting of Interchange Fees in the Visa Debit Payment System

## Objective

The objective of this Standard is to ensure that the setting of interchange fees in the designated Visa Debit payment system promotes:

- (i) efficiency; and
- (ii) competition

in the Australian payments system.

## Application

- 1. This Standard is determined under Section 18 of the *Payment Systems (Regulation) Act* 1998.
- 2. This Standard applies to the payment system operated within Australia known as Visa Debit, which was designated as a payment system on 18 February 2004.
- 3. In this Standard:

an 'acquirer' is a participant in the Visa Debit system that provides services to a merchant to allow that merchant to accept a Visa Debit card;

'credit card transaction' has the meaning it has in Standard No. 1;

'Visa Debit card' means a card issued by a participant in the Visa Debit payment system, under the rules of the Scheme, that allows the cardholder to make payments to merchants for goods and services by accessing a deposit account held at the participant;

'Visa Debit card transaction' means a transaction in Australia between a debit cardholder and a merchant involving the purchase of goods and services using a Visa Debit card;

'financial year' is the 12-month period ending 30 June;

an 'issuer' is a participant in the Visa Debit system that issues Visa Debit cards to its customers;

'merchant' means a merchant in Australia that accepts a Visa Debit card for payment of goods and services;

'reference year' is the financial year prior to the relevant year;

- 'relevant year' is the financial year in which the benchmark must be calculated; terms defined in the *Payment Systems (Regulation) Act 1998* have the same meaning in this Standard.
- 4. This Standard refers to wholesale fees, known as 'interchange' fees, which are payable between an issuer and an acquirer, directly or indirectly, in relation to a Visa Debit card transaction.
- 5. Each participant in the Visa Debit system must do all things necessary on its part to ensure compliance with this Standard.
- 6. If any part of this Standard is invalid, the Standard is ineffective only to the extent of such part without invalidating the remaining parts of this Standard.
- 7. This Standard is to be interpreted:
  - in accordance with its objective; and
  - by looking beyond form to substance.
- 8. This Standard comes into force on [1 July 2006].

## **Interchange Fees**

9. The weighted average of interchange fees in the Visa Debit system in Australia must not exceed the benchmark calculated in accordance with paragraphs 10 and 11 below. The weights to be used in this calculation are shares of transaction values to which each interchange fee rate applies.

## Methodology

- 10. The benchmark is to be calculated by the Reserve Bank using data for the reference year supplied by the credit card schemes designated by the Bank and to whom Standard No. 1 applies.
- 11. The benchmark is to be calculated as follows:
  - a. A cost base is to be calculated for each designated credit card scheme. It is determined by dividing the costs of processing and authorisation described in paragraphs 11(i) and 11(iii) of Standard No. 1 in the reference year by the total value of credit card transactions in the reference year.
  - b. A weighted average of the cost bases in the designated credit card schemes will be calculated. The weights to be used are the shares of the value of credit card transactions in each designated credit card scheme in the value of total credit card transactions in the three designated credit card schemes in the reference year.
  - c. This weighted average will be multiplied by the average value of a Visa Debit card transaction in the reference year to yield a benchmark expressed as a number of cents per transaction.

- 12. The Reserve Bank will calculate the benchmark by [15 September] of the relevant year and publish it on its website.
- 13. Interchange fees in the Visa Debit system must conform with the benchmark from [31 October] in the relevant year.

## Initial and subsequent benchmarks

- 14. For the initial benchmark the relevant financial year is [2006/07].
- 15. The benchmark is to be recalculated in the financial year [2009/10] and every three years thereafter.

## Transparency

- 16. The administrator of the Visa Debit system must publish the interchange fees applying to Visa Debit transactions on its website.
- 17. The administrator of the Visa Debit system must certify in writing to the Reserve Bank by 30 September each year, that interchange fees in the Visa Debit system complied with this Standard over the previous financial year. In the first year, this requirement applies to the [8] months ending [June 2007].

This notice is published in accordance with the requirements set out in Section 28 (2) of the Payment Systems (Regulation) Act 1998 (the Act).

The Reserve Bank of Australia proposes to determine in accordance with Section 18 of the Act the following standard to be complied with by the participants in the Visa Debit system and the Visa credit card system:

Standard No. 5 entitled The 'honour all cards' rules in the Visa Debit and Visa credit card systems and the 'no surcharge' rule in the Visa Debit system.

## Summary of purpose and effect of proposed Standard No. 5

The purpose of proposed Standard No. 5 is to ensure that the rules of the Visa Debit system and the Visa credit card system promote efficiency and competition in the Australian payments system.

The Standard prevents the rules of the schemes and participants in the schemes from requiring that merchants accept Visa Debit cards as a condition of accepting Visa credit cards and vice versa. The effect will be to give merchants the freedom to make separate choices about which cards to accept.

The Standard also prevents the rules of the Visa Debit system and the participants in this system from prohibiting a merchant from charging a Visa Debit cardholder any fee or surcharge for use of a Visa Debit card. The effect will be to allow merchants, if they wish, to charge a 'fee for service' for accepting Visa Debit cards.

## Standard No. 5

## The 'honour all cards' rules in the Visa Debit and Visa credit card systems and the 'no surcharge' rule in the Visa Debit system

## **Objective**

The objective of this Standard is to ensure that the rules of the Visa Debit system and the Visa credit card system promote:

- (i) efficiency; and
- (ii) competition

in the Australian payments system.

## **Application**

- 1. This Standard is determined under Section 18 of the *Payment Systems (Regulation)*Act 1998.
- 2. This Standard applies to the payment system operated within Australia known as Visa Debit, which was designated as a payment system on 18 February 2004 and to the Visa credit card system operated within Australia known as the Visa system or the Visa network card system which was designated as a payment system on 11 April 2001.
- 3. In this Standard:

an 'acquirer' is a participant in the Visa Debit system that provides services to a merchant to allow that merchant to accept a Visa Debit card;

'credit card' has the meaning it has in Standard No. 1;

'credit transaction' means a transaction in Australia between a credit cardholder and a merchant involving the purchase of goods or services using a credit card;

'financial year' is the 12-month period ending 30 June;

'Visa Debit card' means a card issued by a participant in the Visa Debit payment system, under the rules of the Scheme, that allows the cardholder to make payments to merchants for goods and services by accessing a deposit account held at the participant;

'Visa Debit card transaction' means a transaction in Australia between a Visa Debit cardholder and a merchant involving the purchase of goods and services using a Visa Debit card;

an 'issuer' is a participant in the Visa Debit system that issues Visa Debit cards to its customers;

'merchant' means a merchant in Australia that accepts a Visa Debit card for payment of goods and services;

'rules of the Scheme' means the constitution, rules, by-laws, procedures and instruments of the Visa Debit system and the Visa credit card system as applied in Australia, and any other arrangement relating to the scheme by which participants consider themselves bound;

terms defined in the *Payment Systems (Regulation) Act* 1998 have the same meaning in this Standard.

- 4. Each participant in the Visa Debit system and the Visa credit card system must do all things necessary on its part to ensure compliance with this Standard.
- 5. If any part of this Standard is invalid, the Standard is ineffective only to the extent of such part without invalidating the remaining parts of this Standard.
- 6. This Standard is to be interpreted:
  - in accordance with its objective; and
  - by looking beyond form to substance.
- 7. This Standard comes into force on [1 July 2006.]

## Merchant pricing

- 8. Neither the rules of the Scheme nor any participant in the Visa Debit system shall prohibit a merchant from charging a Visa Debit cardholder any fee or surcharge for a Visa Debit card transaction.
- 9. Notwithstanding paragraph 8, an acquirer and a merchant may agree that the amount of any such fee or surcharge charged to a Visa Debit cardholder will be limited to the fees incurred by the merchant in respect of a Visa Debit card transaction.

## Honouring cards

10. Neither the rules of the Scheme nor a participant in the Visa Debit system or Visa credit card system may require a merchant to accept Visa Debit cards as a condition of the merchant also accepting Visa credit cards. Likewise, neither the rules of the Scheme nor a participant in the Visa Debit system or Visa credit card system may require a merchant to accept Visa credit cards as a condition of the merchant also accepting Visa Debit cards.

## Transparency

11. Visa Debit cards must be identifiable as such, both visually and electronically.

12. The administrator of the Visa Debit system and Visa credit card system must certify in writing to the Reserve Bank by 30 September each year that the Visa Debit system and Visa credit card system and participants in those systems complied with this Standard in the previous financial year.

## Finding in relation to continuation inquiry

## Notice pursuant to 269ZHG(1) of the Customs Act 1901

The Australian Customs Service has completed its inquiry into whether the expiration of the countervailing measures applying to bulk brandy exported from France would lead, or would be likely to lead, to a continuation of, or a recurrence of, the material injury that the measures are intended to prevent.

Customs findings are detailed in Trade Measures Report No. 85. In this report Customs recommended that the countervailing measures that are to expire after 27 February 2005 should not continue after the specified expiry date.

I, CHRISTOPHER MARTIN ELLISON, Minister for Justice and Customs, have considered, and accept, the recommendations of Customs, the reasons for the recommendations and the material findings of fact on which the recommendations are based.

Accordingly, I declare that I have decided not to secure the continuation of countervailing measures currently applying to bulk brandy exported from France, which expire on 27 February 2005.
