- (c) Section 63 of the Act provides that a carrier licence may be subject to any conditions declared by the Minister administering the Act including:
 - (i) conditions, in addition to those referred to under sections 61 and 62 of the Act, applying to all carrier licences; and
 - (ii) conditions applying to specified carrier licences (the licences can be specified by name, by class or in any other way).

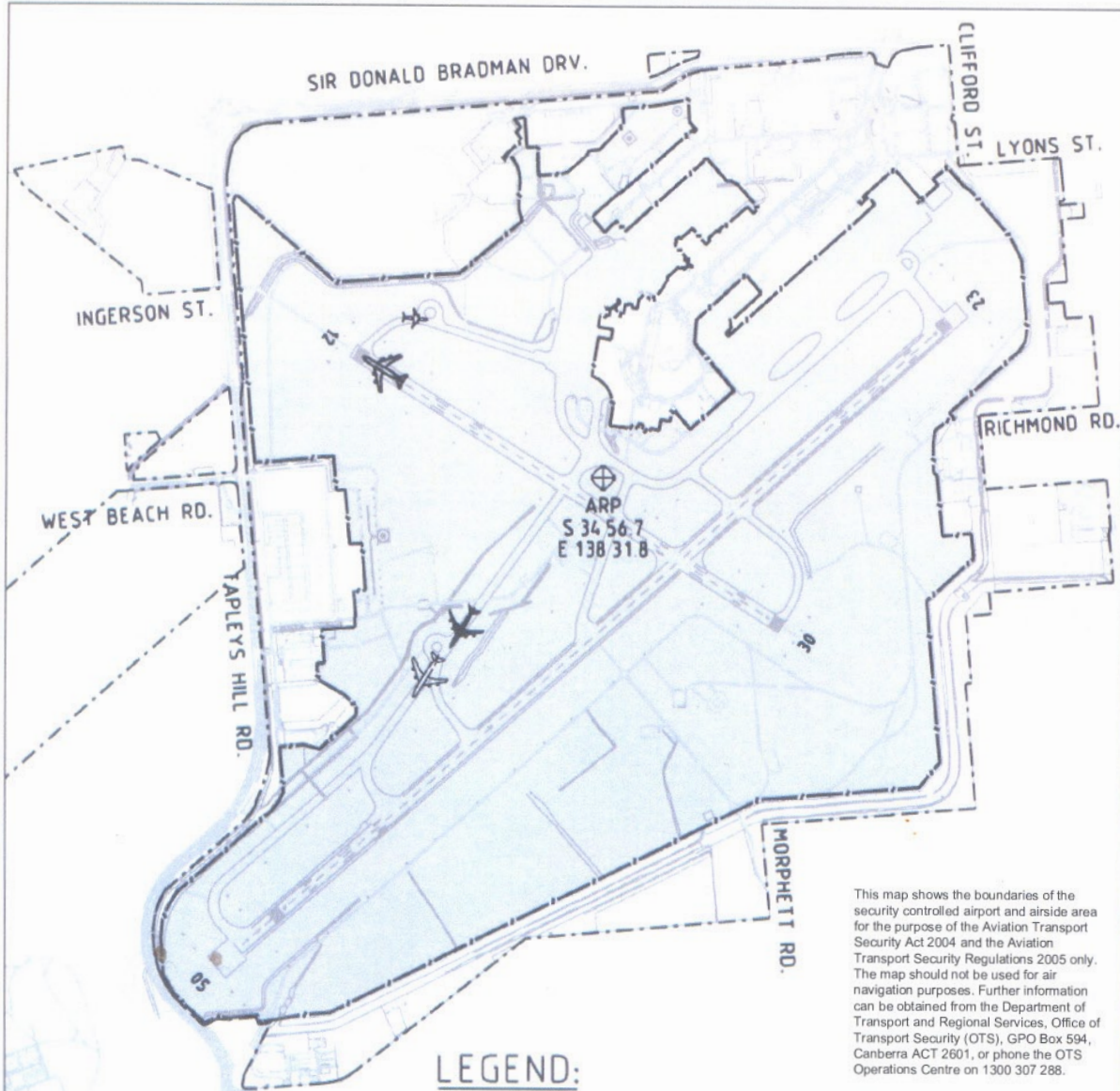

The data requested will also include name and address details of the individual who is the main service provider to the entity. These sources are identified at Attachment A.

The information collected will be electronically matched with certain sections of Tax Office data holdings to identify non compliance with lodgment and payment obligations under taxation law. Records relating to approximately 100,000 individuals and entities who have received contract payments from the listed labour hire firms, placement agencies and computer consultancies will be matched.

This program is called the PSI Data Matching Project and enables the Tax Office:

- To identify and address non compliance through electronic bulk data matching; and
