



  - (b) a payment made to an employee as a result of the shortening of a retention period;
  - (c) an incentive payment to retire.
- (2) Each of the following payments is not a redundancy benefit:
  - (a) a payment made:
    - to a person who was engaged for a specified term or for the duration of a specified task; and
    - (ii) as compensation for the early cessation of the person's employment;
  - (b) a payment made to a person if:
    - (i) the person was engaged overseas to perform duties overseas as an employee under section 74 of the Act; and
    - (ii) the person's employment ceased otherwise than at the initiative of the employer.
- (3) The *redundancy benefit period* is the number of weeks following the date of cessation of a person's employment that resulted in the payment of a redundancy benefit. It is calculated as follows:

Redundancy benefit = gross amount of an employee's redundancy benefit weekly salary used to calculate the redundancy benefit

Note a redundancy benefit does not include any payment in lieu of notice made to the employee.

#### [2] Clause 4.4A

Replace clause 4.4A with the following

# 4.4A Restrictions on engagement of redundancy benefit recipients as APS employees or locally engaged employees

- (1) In this clause, a person is a redundancy benefit recipient if:
  - (a) the person has received a redundancy benefit from an Agency, or from Parliamentary Service employment; or

- (b) the person received a redundancy benefit from the Murray-Darling Basin Commission, in circumstances where the person did not accept an offer of employment in the APS made under paragraph 72(1)(d) of the Act; and
- (c) the redundancy benefit period has not elapsed.
- (2) An Agency Head may engage a redundancy benefit recipient as an APS employee, or under section 74 of the Act to perform duties overseas as an employee, only if the Agency Head considers that the engagement is essential for the Agency's operations, having regard to the nature of the duties to be performed and the skills, experience or qualifications of the person.
- (3) In addition to the requirement in subclause (2) above, an Agency Head must also:
  - (a) obtain the Commissioner's approval before engaging a redundancy benefit recipient as either:
    - (i) an ongoing APS employee; or
    - (ii) a non-ongoing SES employee;
  - (b) consult with the Commissioner before engaging a redundancy benefit recipient, where the engagement is:
    - (i) as a non-ongoing APS employee (at a non-SES classification) for a specified term of more than 6 months; or
    - (ii) as a non-ongoing APS employee (at a non-SES classification) for the duration of a specified task where it is estimated that the duration of the task is likely to be more than 6 months; or
    - (iii) to perform duties overseas as an employee under section 74 of the Act;
  - (c) consult with the Commissioner before extending the engagement (at a non-SES classification) of a non-ongoing employee who is a redundancy benefit recipient, where the total term of engagement will exceed 6 months.

#### EXPLANATORY STATEMENT

Public Service Act 1999

#### Public Service Commissioner's Amendment Directions 2009 (No. 1)

#### Background

The *Public Service Act 1999* (the Act) and its accompanying Public Service Commissioner's Directions 1999 (the Directions) commenced on 5 December 1999.

Section 11 of the Act provides that the Commissioner must issue directions in relation to each of the Australian Public Service (APS) Values (which are set out in section 10 of the Act) for the purpose of ensuring that the APS incorporates and upholds the Values and for the purpose of determining the scope or application of the Values.

Clauses 4.4 and 4.4A of the Directions set out the arrangements applying in the APS in relation to the employment of persons who have received a redundancy benefit on cessation of their previous employment. These arrangements generally apply to persons who have received a redundancy benefit from an APS Agency or a non-APS Commonwealth employer and it is less than 12 months since the person's previous employment ended. Agency Heads have some discretion to engage redundancy benefit recipients in certain circumstances as set out in clause 4.4A.

Section 42(4) of the Act provides that the Directions are disallowable non-legislative instruments for the purposes of the *Acts Interpretation Act 1901*.

#### Purpose of these amendments

The purpose of Public Service Commissioner's Amendment Directions 2009 (No. 1) is to:

- limit the application of the arrangements applying to the engagement in the APS
  of redundancy benefit recipients to those persons who have received a
  redundancy benefit from an APS agency, a Parliamentary Service Department
  and to certain former employees of the Murray-Darling Basin Commission who
  did not accept an offer of APS employment made under s.72(1)(d) of the Act; and
- provide that the period of exclusion is to be linked to the level of the redundancy benefit received by an individual.

Currently, clauses 4.4 and 4.4A apply to persons who seek employment in the APS after receiving a redundancy benefit from the APS, as well as from a range of non-APS Commonwealth employers. This provision is being amended to exclude non-APS Commonwealth employees from its coverage. An excess non-APS Commonwealth employee typically does not have the option of seeking redeployment within the APS as an alternative to receiving a redundancy benefit from their employer. An exception is for employees of the Parliamentary Service who are able to move at level to jobs in the APS and as a result, Parliamentary Service employees will continue to be covered by the scope of clauses 4.4 and 4.4A.

In addition, the Directions were amended on 15 December 2008 to extend the arrangements set out in clauses 4.4 and 4.4A to persons who were formerly employed in the Murray-Darling Basin Commission (MDBC) who did not accept an offer of employment in the APS made under paragraph 72(1)(d) of the Act, and who received

a redundancy benefit or similar payment on cessation of their employment with the MDBC. These arrangements will continue to apply following this amendment.

The uniform 12 month exclusion period that currently applies to persons receiving a redundancy benefit is to be replaced by a period that links the period of exclusion to the level of the redundancy benefit received. Under the new arrangements, a person who receives a redundancy benefit from an APS Agency, a Parliamentary Service Department, or from the Murray-Darling Basin Commission (in the circumstances described above) will generally be excluded from being engaged as an APS employee for a period of weeks that is calculated by dividing the person's gross redundancy benefit on separation (excluding any period of notice) by the person's weekly salary that is used to calculate the redundancy benefit.

The revised coverage of these arrangements, as well as the revised method of calculating the period of exclusion, will apply effective from the date this amendment comes into effect, including to persons who received a redundancy benefit before this date.

There will also continue to be flexibility for an Agency Head to engage a redundancy benefit recipient in circumstances where the redundancy benefit period has not expired. The Directions will continue to set out the steps an Agency Head must follow prior to engaging such a person, including the circumstances where it is necessary to either gain the approval of the Public Service Commissioner, or consult with the Public Service Commissioner, prior to the engagement.

The Australian Public Service Commission has consulted with the Department of the Prime Minister and Cabinet, the Department of Finance and Deregulation, the Department of Education, Employment and Workplace Relations and the Department of Defence on these amendments.

#### Notes on clauses

Clause 1 sets out the name of the Directions.

Clause 2 provides for the Directions take effect on 1 March 2009.

Clause 3 provides that the amendments to the Directions are set out in Schedule 1.

#### Schedule 1

**Item 1** Item 1 replaces clause 4.4 with a new clause 4.4.

Subclause 4.4(1) has been redrafted to remove any references to the agency or employer that paid the redundancy benefit, as this will now be covered in subclause 4.4A(1). It now simply lists the types of payments that fall within the defintion of a redundancy benefit.

Similarly, subclause 4.4(2) has also been amended to remove any references to the employer, thereby enabling existing subclauses 4.4(2)(a) and 4.4(2)(b) to be combined into a single new subclause 4.4(2)(a). Existing subclause 4.4(2)(c) is unchanged but becomes subclause 4.4(2)(b).

A definition of the *redundancy benefit period* has been included in subclause 4.4(3) which is to be used for the purposes of determining the

period a redundancy benefit recipient is covered by the arrangements set out in clause 4.4A.

Item 2 replaces clause 4.4A with a new clause 4.4A.

Subclause 4.4A(1) defines a redundancy benefit recipient as a person who has received a redundancy benefit from an Agency (defined in the Dictionary to the Directions); from Parliamentary Service employment (which will be defined in the Dictionary to the Directions - see item 3 below); or from the Murray-Darling Basin Commission in circumstances where the person did not accept an offer of employment in the APS made under paragraph 72(1)(d) of the Act. References to 'non-APS Commonwealth employment' have been removed from this subclause.

Existing subclauses 4.4A(2), (3) and (4) have been rewritten with the objective of making them clearer.

New subclause 4.4A(2) is essentially the same as existing subclause 4.4A(2)(a).

New subclause 4.4A(3) sets out the circumstances where an Agency Head must either seek the approval of, or consult with, the Public Service Commissioner before engaging a redundancy benefit recipient. The only change of substance is to simplify the consultation requirements by providing that this must occur where a person is to be engaged for a specified term of more than 6 months, or for the duration of a specified task where it is estimated that the duration is likely to be more than 6 months.

- Item 3 Item 3 inserts a new definition of *Parliamentary Service employment* in the Dictionary to the Directions and provides that this term has the meaning given by the *Parliamentary Service Act 1999*.
- Item 4 removes the definition of *non-APS Commonwealth employer* from the Dictionary to the Directions as this term is no longer used in the Directions.

Payment Systems (Regulation) Act 1998

Access Regime for the designated ATM payment system

This notice is published in accordance with the requirements set out in Section 29(2)(a) of the *Payment Systems (Regulation) Act 1998* (the Act).

The Reserve Bank of Australia imposes, in accordance with Section 12 of the Act, the attached Access Regime to be complied with by the participants in the designated ATM payment system.

#### Summary of purpose and effect of the Access Regime

The purpose of the Access Regime is to improve competition and efficiency in the ATM system, including through improved arrangements for new participants to gain access to the ATM system. The Access Regime will operate in conjunction with an ATM Access Code developed by the Australian Payments Clearing Association (APCA), which is available at <a href="https://www.atmaccesscode.com.au">www.atmaccesscode.com.au</a>.

The Access Regime addresses two issues that are not dealt with in APCA's Access Code. The first is the price that incumbents may charge access seekers to directly participate in the ATM system. The second is the potential for interchange fees to be used as a barrier to entry to the system.

In relation to the first issue, the Access Regime has two effects. The first is to cap the access charge that can be levied for establishing a new direct connection at \$76 700 – the lowest estimated cost of implementing such a connection obtained from a survey of ATM connection costs. The second effect of the Access Regime is that no charge may be levied for establishing a direct clearing/settlement service. The Bank views clearing and settlement as fundamental banking business and, provided financial institutions meet appropriate objective prudential standards, they should have the right to clear and settle with other financial institutions, with each institution meeting its own costs.

In relation to interchange fees, the effect of the Access Regime is that no interchange fees may be paid between participants in the ATM system, except in two sets of circumstances. The first is where the interchange fee is paid in respect of a one-way arrangement – where a card issuer pays a fee to an ATM owner to allow its customers access to those ATMs, but reciprocal arrangements do not apply. An issuer can have only one such arrangement in place and, if it does, should not also receive a bilateral fee under a one-way arrangement. The second exception is where the interchange fee

is the common fee paid between members of an ATM sub-network. An ATM sub-network is a component of the ATM system for which access is provided on a multilateral basis, rather than by bilateral negotiation, and for which there is a common, multilateral interchange fee. The Reserve Bank considers that these exceptions will benefit competition by allowing smaller institutions to provide fee-free access to a larger network of ATMs than they could provide themselves. The Access Regime also allows the Reserve Bank to exempt a participant from some or all requirements of the interchange fee provisions if considered appropriate having regard to the Bank's obligations under the Act.

The Access Regime and related industry reforms are expected, over time, to result in a number of benefits. In particular, the reforms will: make the cost of cash withdrawals more transparent to cardholders and strengthen competitive forces on ATM fees; help ensure that there is continued widespread availability of ATMs; and make access less complicated for new entrants and therefore strengthen competition.

#### **Access Regime for the ATM System**

#### Objective

The objective of this Access Regime is to promote competition and efficiency in the Australian payments system, having regard to:

- (i) the interests of current participants in the ATM system;
- (ii) the interests of people who, in the future, may want access to the ATM system;
- (iii) the public interest; and
- (iv) the financial stability of the ATM system.

#### Application

- This Access Regime is imposed under Section 12 of the Payment Systems (Regulation)
   Act 1998.
- 2. This Access Regime applies to the payment system operated within Australia known as the ATM system, which was designated as a payment system on 10 December 2008 and referred to below as the ATM system.
- 3. In this Access Regime:
  - 'Access Provider' has the same meaning as in the ATM Access Code;
  - 'Access Seeker' has the same meaning as in the ATM Access Code;
  - 'APCA' means the Australian Payments Clearing Association Limited (ABN 12 055 136 519);
  - 'APCA's 2008 costs survey' is the survey, conducted by APCA, of the estimated incremental direct costs to Access Providers of providing to an Access Seeker a Direct Connection Service or a Direct Clearing/Settlement Service, the final results of which were supplied to the Reserve Bank of Australia in November 2008;
  - an 'ATM' means an automatic teller machine in Australia;
  - an 'ATM Acquirer' has the same meaning as in the ATM Access Code;
  - 'ATM Access Code' means the ATM Access Code adopted by ATM Access Australia Limited (ABN 53 130 571 103) on 23 February 2009 to commence on 3 March 2009, and as varied from time to time;
  - an 'ATM Issuer' has the same meaning as in the ATM Access Code;
  - an 'ATM sub-network' is a component of the ATM system for which access is provided on a multilateral basis, rather than by bilateral negotiation, and for which there is a common, multilateral interchange fee;

'ATM transaction' means a cash withdrawal, balance enquiry, or any other service obtained from an ATM in the ATM system in Australia;

'Connection Agreement' has the same meaning as in the ATM Access Code;

'Connection Charge' means the charge payable by an Access Seeker to an Access Provider under a Connection Agreement as described in Clause 3 of Schedule 3 of the ATM Access Code;

'Direct Clearing/Settlement Service' has the same meaning as in the ATM Access Code;

'Direct Connection Service' has the same meaning as in the ATM Access Code;

'Direct Connector' means a participant that exchanges ATM transaction messages, and clears and settles ATM transactions using two or more direct connections;

an 'interchange fee' is a wholesale fee which is payable by an ATM Issuer to an ATM Acquirer when a cardholder of the ATM Issuer undertakes an ATM transaction that is acquired by the ATM Acquirer;

a 'one-way arrangement' is an access arrangement whereby an ATM Issuer pays an interchange fee to an ATM Acquirer for use of an ATM by a cardholder, but that same ATM Acquirer does not pay an interchange fee to access any ATMs of the ATM Issuer in the arrangement;

terms defined in the *Payment Systems (Regulation) Act 1998* have the same meaning in this Access Regime.

- 4. Each participant in the ATM system must do all things necessary on its part to ensure compliance with this Access Regime.
- 5. If any part of this Access Regime is invalid, it is ineffective only to the extent of such part without invalidating the remaining parts of this Access Regime.
- 6. This Access Regime is to be interpreted:
  - in accordance with its objective; and
  - by looking beyond form to substance.
- 7. This Access Regime comes into force on 3 March 2009.

#### Price of access

Connection Charge for providing the Direct Connection Service

- 8. The Connection Charge levied by an Access Provider for providing the Direct Connection Service to an Access Seeker must not exceed the Direct Connection Cap, calculated in accordance with paragraph 9 below, applying on the date the Connection Agreement is entered into.
- 9. From 3 March 2009, the Direct Connection Cap for the Connection Charge in the ATM system is the lowest estimated cost for providing a Direct Connection Service as measured in APCA's 2008 costs survey. This cost is \$76 700 (excluding GST).

#### Connection Charge for providing the Direct Clearing/Settlement Service

10. From 3 March 2009, no charge may be levied between participants in the ATM system for providing the Direct Clearing/Settlement Service.

#### Interchange fees

- 11. From 3 March 2009, no interchange fee shall be paid between participants in the ATM system in relation to any ATM transaction, unless the interchange fee is being paid by:
  - (i) a participant with a one-way arrangement to access one, and only one, other participant's ATMs and the fee is paid in respect of this arrangement; or
  - (ii) a participant that is a member of an ATM sub-network and the fee is the common interchange fee payable between the members of the sub-network, and the fee is paid to another member of that sub-network.
- 12. A participant that pays an interchange fee in a one-way arrangement cannot receive an interchange fee from any other participant in the ATM system unless both those participants are members of an ATM sub-network and the interchange fee is the common interchange fee payable between members of the sub-network.

#### Transparency

- 13. Each ATM Acquirer in the ATM system that receives an interchange fee within the terms of sub-paragraph 11(i) must report that arrangement to the Reserve Bank of Australia no later than 3 April 2009 for existing arrangements or within thirty days of the date the arrangement is entered into for new arrangements.
- 14. The administrator of an ATM sub-network or a representative of the participants in an ATM sub-network must publish the multilateral interchange fee of the sub-network on the administrator's website or on a representative of the participants' website, or make the multilateral interchange fee generally available through other means.
- 15. The administrator of an ATM sub-network must publish the rules that govern access to the sub-network.

#### Exemptions from paragraph 11 of this Regime

- 16. The Reserve Bank may grant an exemption to a participant in the ATM system from any or all of the requirements of paragraph 11 where it is satisfied that the exemption is appropriate, having regard to:
  - (a) whether granting the exemption would be in the public interest;
  - (b) the interests of current participants in the system;
  - (c) the interests of people who, in the future, may want access to the system; and
  - (d) any other matters the Reserve Bank considers relevant.
- 17. Where the Reserve Bank grants an exemption it will publish notice on its website that an exemption has been granted, the nature of the exemption and the identity of the participant(s) involved.

#### Corporations Act 2001

#### Notice of Variation of Financial Stability Standard

The Reserve Bank of Australia ('Reserve Bank'), under section 827D(6) of the Corporations Act 2001, hereby varies the Financial Stability Standard for Central Counterparties. The effect of this variation is to exempt an overseas central counterparty from assessment against the Standard, provided that it is subject to sufficiently equivalent regulation overseas and able to provide documentary evidence from the regulator that it meets the requirements of that regime. This regime will ensure the robustness of central counterparties providing services to Australian markets, while placing appropriate reliance on overseas regulators so as to avoid unnecessary duplication of regulation. Such reliance is explicitly contemplated in the Corporations Act, with Section 823CA stating that 'the Reserve Bank may take account of any information and reports that it thinks appropriate, including information and reports from an overseas regulatory authority'.

The Standard, as varied, is designed to ensure that clearing and settlement (CS) facility licensees conduct their affairs in a way that promotes the overall stability of the Australian financial system.

#### THE STANDARD - FSS 2009.1

A CS facility licensee must conduct its affairs in a prudent manner, in accordance with the standards of a reasonable facility in contributing to the overall stability of the Australian financial system, to the extent that it is reasonably practicable to do so. This Standard applies to all CS facility licensees that operate a central counterparty with the exception of those CS facility licensees granted a licence under Section 824B(2) of the *Corporations Act 2001*. This exception applies only for such time as the Reserve Bank receives annual documentary evidence from the licensee's overseas regulator that the licensee has complied in all material respects with the requirements of the overseas regulator related to matters affecting stability. Such evidence must be provided in a form and at a time agreed with the Reserve Bank.

#### How a licensee meets the Standard

The Standard is supplemented by guidance as to how a CS facility licensee meets the Standard. That guidance is varied as follows:

The Standard does not apply to CS facility licensees granted a licence under Section 824B(2). This exception applies only for such time as the Reserve Bank receives annual documentary evidence from the licensee's overseas regulator that the licensee has complied in all material respects with the requirements of the overseas regulator related to matters affecting stability. The required form of such documentary evidence will be discussed with the licensee and its overseas regulator, but it is expected that it would include the following: details of any assessments carried out over the preceding period relevant to the licensee's compliance with the requirements of the overseas regulator; and details of any specific areas of investigation by the regulator.

2.

Such documentary evidence must be received prior to the commencement of operations under the licence and on an annual schedule thereafter.

The Reserve Bank will also, from time to time, seek additional information directly from the licensee regarding its activities and risk management processes. Furthermore, notwithstanding that an overseas regime may be sufficiently equivalent to that in Australia, there may be some differences in the detailed application of principles or standards. The Reserve Bank will, in such cases, seek sufficient information to carry out a direct assessment of the CS facility licensee in respect of specific aspects of its operations. Subject to the outcome of such an assessment, the Reserve Bank may recommend that additional risk-mitigating actions be taken by the licensee.

At a minimum the Reserve Bank would expect to receive the following information on a regular basis:

- details of any material changes in the licensee's activities, processes, or people: The licensee is expected to provide activity reports and information on material changes in the conduct of its business including changes to products, people and operational processes. The Reserve Bank expects to be informed in advance where material changes in these areas might be relevant to an assessment of systemic risk. Audited annual accounts, quarterly management accounts and data detailing stress-test outcomes relative to the facility's risk resources would also be expected; and
- additional information to allow assessment of specific aspects of the licensee's operations: The form and scope of the information necessary to carry out such an assessment will differ according to the coverage of the overseas regime. The Reserve Bank's expectations in this regard will be discussed periodically with the licensee.

In some cases it may be appropriate to establish a formal framework for cooperative oversight alongside the overseas regulator. Under such circumstances, the required level and frequency of information flow from both the regulator and the facility might be greater.

The varied Financial Stability Standard applies to CS facility licensees from 24 February 2009.

#### Corporations Act 2001

#### Notice of Variation of Financial Stability Standard

The Reserve Bank of Australia ('Reserve Bank'), under section 827D(6) of the Corporations Act 2001, hereby varies the Financial Stability Standard for Securities Settlement Facilities.

Among other requirements, the previous Standard required a securities settlement facility to make sufficient information available to participants, such that they are able to gauge the risks they may face through their participation in the facility. Following a review of settlement practices, the Reserve Bank concluded that greater transparency of equities securities-lending activity could assist participants to assess their vulnerability to settlement risks arising from activity in this market. Greater visibility of securities-lending transactions would also assist the system operator itself in its day-to-day management of risks arising in the batch settlement process.

The Standard, as varied, is designed to ensure that clearing and settlement (CS) facility licensees conduct their affairs in a way that promotes the overall stability of the Australian financial system.

#### THE STANDARD - FSS 2009.2

A CS facility licensee must conduct its affairs in a prudent manner, in accordance with the standards of a reasonable facility in contributing to the overall stability of the Australian financial system, to the extent that it is reasonably practicable to do so.

This Standard only applies to CS facility licensees that provide a facility where the value of financial obligations settled in a financial year exceeds a threshold value of \$100 million. When this threshold is exceeded for the first time, the provider of the facility must meet the Standard by the beginning of the next financial year.

#### How a licensee meets the Standard

The Standard is supplemented by a series of minimum measures and guidance as to how a CS facility licensee meets the Standard.

Measure 3 is varied to read:

The securities settlement facility must make sufficient information publicly available, via its rules and procedures and the provision of relevant information on settlement activity, such that each participant is able to understand the securities settlement facility's impact on each of the financial risks the participant incurs through participation in the facility.

The Guidance to Measure 3 is varied as follows:

The operator of a securities settlement facility should supplement clear, comprehensive and up-to-date rules and procedures with other information and

data relevant to a participant's understanding of the risks associated with participation in the facility. For instance, participants should have access to sufficiently timely and broadly comprehensive data on equities securities lending to enable them to assess the potential implications for settlement risk. This is particularly important where equities securities loans are bilaterally negotiated and not novated to a central counterparty, but nevertheless settled alongside novated exchange-traded transactions.

The varied Financial Stability Standard applies to CS facility licensees from 24 February 2009.

I am satisfied on those matters specified in section 303FN of the EPBC Act. I hereby declare the operations for the harvesting of specimens that are, or are derived from, fish or invertebrates, other than specimens of species listed under Part 13 of the EPBC Act, taken in the Queensland East Coast Inshore Fin Fish Fishery, as defined in the management regime for the fishery, made under the Queensland *Fisheries Act 1994* and the Queensland Fisheries Regulation 2008 to be an approved Wildlife Trade Operation, in accordance with subsection 303FN (2) and paragraph 303FN(10)(d), for the purposes of the EPBC Act.

Declaration of the Harvest Operations of the Queensland East Coast Inshore Fin Fish Fishery as an approved Wildlife Trade Operation February 2009

#### ADDITIONAL PROVISIONS (section 303FT)

Relating to the harvesting of fish specimens that are, or are derived from, fish or invertebrates, other than specimens of species listed under Part 13 of the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act), taken in the Queensland East Coast Inshore Fin Fish Fishery, made under the Queensland *Fisheries Act 1994* and the Queensland Fisheries Regulation 2008.

- Operation of the fishery will be carried out in accordance with the Queensland
  East Coast Inshore Fin Fish Fishery (ECIFFF) management regime in force under
  the Queensland Fisheries Act 1994 and the Queensland Fisheries Regulation
  2008.
- The Queensland Department of Primary Industries and Fisheries (DPI&F) to inform the Department of the Environment, Water, Heritage and the Arts (DEWHA) of any intended amendments to the ECIFFF management arrangements that may affect the assessment of the fishery against the criteria on which EPBC Act decisions are based.
- 3. DPI&F to produce and present reports to DEWHA annually as per Appendix B to the *Guidelines for the Ecologically Sustainable Management of Fisheries 2nd Edition.*
- 4. DPI&F to introduce a logbook for 'S' symbol holders by 1 July 2009, that will provide information on all catches, better recording of effort and species-specific data on chondrichthyan catch (linked to new Shark Identification Guide for Queensland Fishers), including as a minimum:
  - blacktip (Carcharhinus tilstoni and C. limbatus);
  - spot-tail (C. sorrah);
  - milk and Australian sharpnose (Rhizoprionodon acutus and R. taylori); and
  - hammerhead (*Sphyrna* spp) and where necessary the product form of retained catch.
- 5. By 1 July 2009, DPI&F to implement a statistically robust observer program for 'S' symbol holders.

6.

- a) By 30 March 2010, DPI&F is to investigate and report to DEWHA on an appropriate catch validation system, with monitoring to provide confidence in these data, to verify sales against landings and to cross check logbook catch data with catch landing data.
- By 1 July 2011, DPI&F is to implement the outcomes of the investigation in Condition 6a).

7. By 1 July 2009, DPI&F to set a total allowable commercial catch (TAC) of no more than 600 tonnes for chondrichthyans.

8.

- a) DPI&F to conduct annual reviews of the management arrangements for the shark fishery, including the TAC, and report to DEWHA by 1 December each year. Reports will include at a minimum:
  - · analysis of catch composition;
  - analysis of spatial distribution of catch by species;
  - · update of risk assessments for individual species; and
  - once sufficient data is available, stock assessments for species caught in the fishery.
- DPI&F to revise management arrangements as appropriate following annual reviews.
- By 1 December 2010, DPI&F to report to DEWHA on the implementation and continued improvement of the harvest strategy for sharks, including progress towards species-based management.
- By 1 July 2009, DPI&F to close the Bizant, Normanby and Kennedy Rivers to netting.
- 11. By 1 July 2009, DPI&F to introduce a requirement for high risk chondrichthyan species which are permitted to be retained, to be landed with the fins naturally attached. High risk species include: white spotted guitar fish (*Rhynchobatus* spp), whitetip reef sharks (*Triaenodon obesus*) and grey reef sharks (*C. amblyrhynchos*).
- 12. By 1 December 2009, DPI&F to examine and report on the significance of conservation benefits of spatial closures in:
  - a) areas where fishing effort overlaps with important habitats for speartooth shark, sawfish, dugong and inshore dolphins; and
  - b) waters north of Cooktown to mesh net fishing to provide additional protection to these species.
- By 1 July 2009, DPI&F to finalise and implement the performance measurement system for the ECIFFF.
- 14. By 1 July 2009, DPI&F to review and lower the proposed trigger for effort from 34,000 net days to more closely reflect the average level of effort in the fishery over the last two years.
- 15. By 1 July 2009, DPI&F to determine an appropriate management response to be implemented if the effort trigger as identified by Condition 14 is reached.
- 16. By 1 December 2010, DPI&F to review management arrangements for the ECIFFF and investigate additional management measures to control catch and effort, including consideration of regional management.

- 17. By 31 December 2011, DPI&F to implement the outcomes of the review described in Condition 16.
- 18. By 1 July 2009, DPI&F to set a precautionary commercial TAC for grey mackerel (*Scomberomorus semifasciatus*), taking into account all sources of mortality.

NSW DPI to review its current management arrangements for Eastern Gemfish, and where appropriate, in collaboration with AFMA and other jurisdictions, develop and implement timely and complementary management arrangements that assist to stop the decline of, and support the recovery of Eastern Gemfish stocks.
