Use Classifications to Choose Computer Games and Films



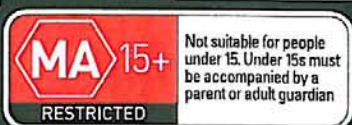



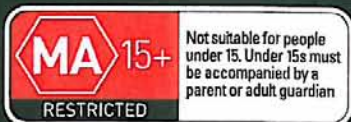

- (a) the National Director has reasonable grounds to believe that a publication is a submittable publication; and
- (b) the publication is being published in South Australia, or the National Director has reasonable grounds to believe that it will be published in South Australia,

the National Director may, by notice in writing given to the publisher of the publication, require the publisher to submit an application for classification of the publication, or of subsequent issues of the publication, by the National Board.

'Submittable publication' is defined in section 5 of the *Classification (Publications, Films and Computer Games) Act 1995* (Cth) (the Classification Act) to mean:

an unclassified publication that, having regard to section 9A or to the Code and the classification guidelines to the extent that they relate to publications, contains depictions or descriptions that:

- (a) are likely to cause the publication to be classified RC; or

- (b) are likely to cause offence to a reasonable adult to the extent that the publication should not be sold or displayed as an unrestricted publication; or
- (c) are unsuitable for a minor to see or read.

‘Publish’ is defined in section 5 of the Classification Act to include ‘sell, offer for sale, let on hire, exhibit, display, distribute and demonstrate’.

It is an offence in South Australia to sell or deliver a submittable publication: subsection 46(2) of the *Classification (Publications, Films and Computer Games) Act 1995* (SA).





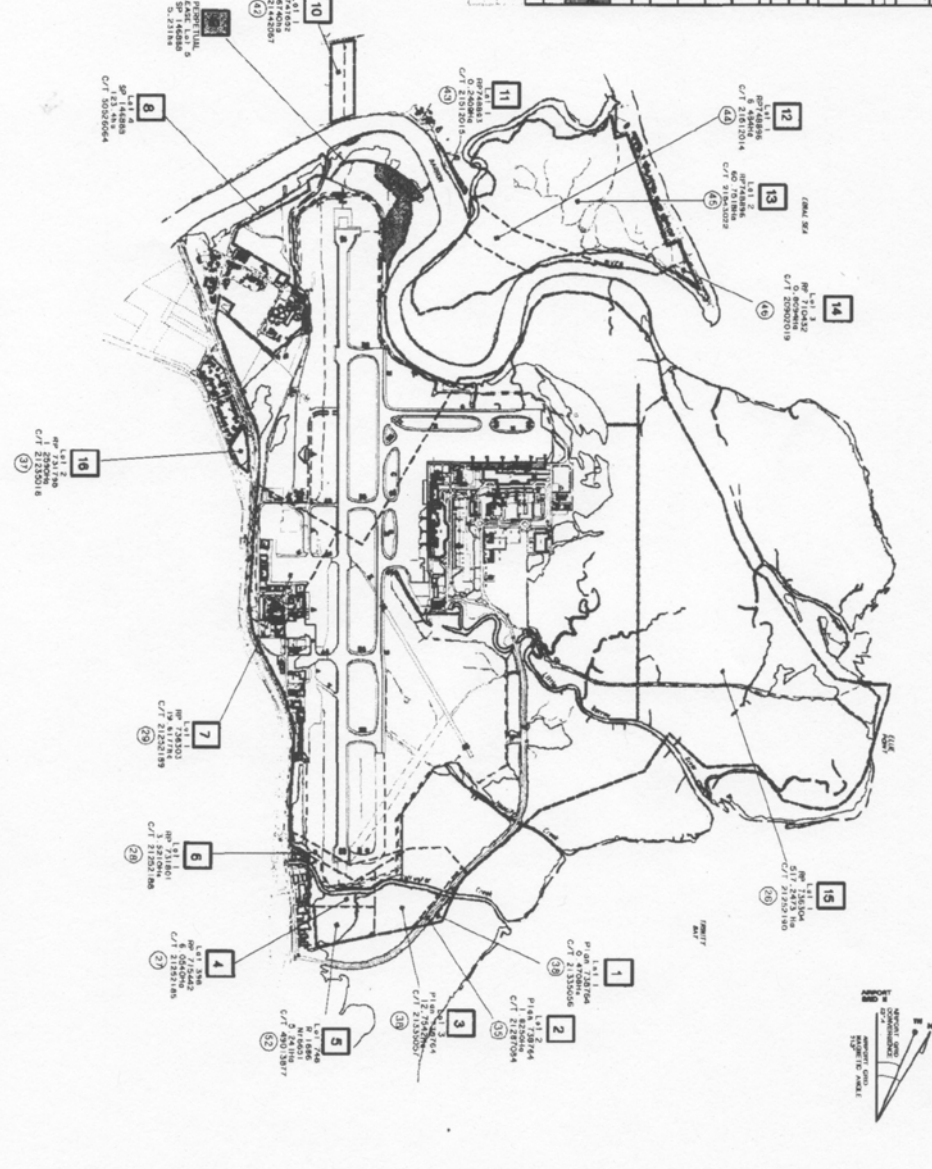

I, Peter Robert Garrett, Minister for the Environment, Heritage and the Arts, provide the following information concerning my decision to vary an approval granted under section 13 of the *Fuel Quality Standards Act 2000* (the Act) pursuant to subsection 33(3) of the *Acts Interpretation Act 1901*.

Name of approval holder

A variation has been granted to The National Biofuels Group Pty Ltd (NBG) for an approval granted on 26 February 2009 (the Approval). The Approval varies the Fuel Standard (Automotive Diesel) Determination 2001 (the Diesel Determination) so that diesel containing more than 5 per cent, but no greater than 20 per cent biodiesel, will be taken to comply with the biodiesel parameter in the Diesel Determination.

Period of operation

The period of operation of the variation to the Approval is from the date of signing until 1 March 2011.

Details of the approval variation

The purpose of the variation is to add four regulated persons (as set out in the instrument of variation) to the Approval.

Background

Pursuant to subsection 33(3) of the *Acts Interpretation Act 1901*, I must have regard to the matters set out in section 15 of the Act before deciding whether or not to vary the Approval:

- (a) The protection of the environment.
- (b) The protection of occupational and public health and safety.
- (c) The interests of consumers.
- (d) The impact on economic and regional development.

I may also have regard to any other matters I consider relevant.

Pursuant to subsection 33(3) of the *Acts Interpretation Act 1901*, I must also consult, and have regard to the recommendations of, the Fuel Standards Consultative Committee (the Committee) before deciding to vary an approval granted under section 13 of the Act as

required by section 24A of the Act. Before signing the instrument granting the variation to the Approval, I consulted with the Committee and had regard to the recommendations it made in October 2009.

Findings on material questions of fact

(a) The protection of the environment

The addition of four regulated persons to NBG's approval is unlikely to significantly add to the volume of fuel that will be supplied under the approval, and therefore is unlikely to have any additional effect on the environment.

(b) The protection of occupational and public health and safety

No additional effect on occupational and public health and safety is expected from the addition of four regulated persons to NBG's approval.

(c) The interest of consumers

The addition of four regulated persons to NBG's approval increases the options for fuel supply to consumers.

(d) The impact on economic and regional development

Four regional companies will benefit from their listing as NBG's regulated persons. This may help support employment in regional areas of New South Wales and Victoria.

Summary of reasons for variation of the approval

1. The volume of fuel to be supplied under the approval is unlikely to increase with additional regulated persons and therefore no additional effect on the environment is expected.
2. The addition of four regulated persons to NBG's approval provides additional choice to consumers for the supply of this fuel.
3. NBG contributes to regional economies in New South Wales and Victoria.

1. The diesel and biodiesel used to create the blends covered by this approval must, before the two fuels are blended, comply with the applicable fuel standards for automotive diesel and biodiesel, i.e. specified in the Fuel Standard (Automotive Diesel) Determination 2001 and the Fuel Standard (Biodiesel) Determination 2003.
2. The approval holder is to provide quarterly reports to the Department of the Environment, Water, Heritage and the Arts (the department) specifying:
 - (i) the volume of fuel supplied under this approval regardless of derived cetane number (DCN)
 - (ii) the cetane values, where available, of each crude supply and each refined diesel supply produced for blending with biodiesel
 - (iii) the cetane values of each biodiesel supply used to produce each batch of diesel/biodiesel blend fuel, and
 - (iv) the DCN of monthly samples of the fuel supplied under this approval.

NB: The reporting periods are for supply during: 1 January to 31 March, 1 April to 30 June, 1 July to 30 September and 1 October to 31 December, each year. Reports are due within one month after the end of the reporting period.

3. The approval holder is to provide a report to the department on its progress towards achieving compliance with the DCN parameter in the automotive diesel standard beyond the approval period with the report being due on 31 May 2010. The report is to include the results of research and analysis of cetane in the approval holder's crude diet, including cetane values for raw, refined and blended product and discussion and analysis of cetane improvers.

DIESEL) DETERMINATION 2001**

I, Peter Robert Garrett, Minister for the Environment, Heritage and the Arts provide the following information concerning my decision to grant an approval under section 13 of the *Fuel Quality Standards Act 2000* (the Act).

Name of approval holder

Approval has been granted to Caltex Australia Petroleum Pty Limited.

Period of operation

The period of operation of the approval is from the date of signing until 30 November 2010.

Details of the approval

This approval varies the fuel standard for diesel set out in the Fuel Standard (Automotive Diesel) Determination 2001 (the Diesel Determination) such that diesel containing biodiesel up to five per cent volume by volume, with a minimum derived cetane number (DCN) of 46, will be taken to comply with the Diesel Determination.

Background

Section 15 of the Act provides that I must have regard to the following when deciding whether or not to grant or amend an approval:

- (a) The protection of the environment.
- (b) The protection of occupational and public health and safety.
- (c) The interests of consumers.
- (d) The impact on economic and regional development.

I may also have regard to any other matters I consider relevant.

Section 24A of the Act provides that I must consult, and have regard to the recommendations of, the Fuel Standards Consultative Committee (the Committee) before granting an approval under section 13. Before signing the instrument granting the approval, I consulted with the Committee and had regard to the recommendations it made in October 2009.

Findings on material questions of fact

(a) The protection of the environment

The DCN of diesel containing biodiesel is a measure of the fuel's ignition qualities. As the automotive diesel standard permits a minimum cetane index of 46 for mineral diesel it is not expected that the approval will cause significant environmental impacts.

(b) The protection of occupational and public health and safety

It is unlikely that occupational and public health and safety will be significantly affected by a variation in DCN for the fuel subject to the approval.

(c) The interests of consumers

Although variations in cetane level can affect engine performance, the fuel subject to the approval is not expected to have significant impacts on consumers.

(d) The impact on economic and regional development

The approval is expected to allow the development of new markets. Not approving the variation may have detrimental impacts on the development of the Australian biodiesel industry.

Summary of reasons for the approval

1. There should not be significant impacts on the environment or occupational and public health and safety caused by the fuel subject to the approval compared with the supply of similar amounts of automotive diesel meeting the fuel standard.
2. It is not expected that significant consumer impacts will be caused by the use of the fuel subject to the approval.
3. There appears to be considerable benefits to the ongoing development of the biodiesel industry in Australia by the granting of the approval.

3. Users and downstream suppliers are to be informed in writing prior to entering into contractual arrangements for supply of the fuel that the fuel varies from the standard and in which respects it varies from the standard.
4. The approval holder is to provide six-monthly reports to the Department of the Environment, Water, Heritage and the Arts (the department) specifying:
 - (i) the volume of fuel supplied under the approval regardless of density
 - (ii) the density readings, where available, of each crude supply and each refined diesel supply produced for blending with biodiesel under the approval
 - (iii) the density readings of each biodiesel supply used to produce each batch of blended fuel under the approval, and
 - (iv) the density readings of monthly samples of final blended diesel product for release to customers.

NB: The reporting periods are for supply during 1 April to 30 September and 1 October to 31 March each year. Reports are due within one month after the end of the reporting period.

5. The approval holder is to provide a report to the department by 31 October 2010 detailing its strategy to comply with the density parameter of the diesel standard regarding supplies of diesel/biodiesel blends after this approval period ends.

I, Peter Robert Garrett, Minister for the Environment, Heritage and the Arts provide the following information concerning my decision to grant an approval under section 13 of the *Fuel Quality Standards Act 2000* (the Act).

Name of approval holder

Approval has been granted to Caltex Australia Limited.

Period of operation

The period of operation of the approval is from the date of signing until 1 March 2011.

Details of the approval

This approval varies the fuel standard for diesel set out in the Fuel Standard (Automotive Diesel) Determination 2001 (the Diesel Determination) such that diesel containing 20 per cent biodiesel volume by volume and having a density of at least 820 kg/m³ and not more than 860 kg/m³ will be taken to comply with the Diesel Determination.

Background

Section 15 of the Act provides that I must have regard to the following when deciding whether or not to grant or amend an approval

- (a) The protection of the environment.
- (b) The protection of occupational and public health and safety.
- (c) The interests of consumers.
- (d) The impact on economic and regional development.

I may also have regard to any other matters I consider relevant.

Section 24A of the Act provides that I must consult, and have regard to the recommendations of, the Fuel Standards Consultative Committee (the Committee) before granting an approval under section 13. Before signing the instrument granting the approval, I consulted with the Committee and had regard to the recommendations it made in October 2009.

Findings on material questions of fact

(a) The protection of the environment

Tailpipe emissions from diesel/biodiesel blend use, compared to diesel, will have both positive and negative impacts on air quality as the level of biodiesel in the blend increases. In general, emissions of nitrogen oxides increase but particulate matter, hydrocarbons and carbon monoxide emissions all decrease. The higher density of the fuel of the fuel subject to the approval is not expected to cause significant environmental impacts.

(b) The protection of occupational and public health and safety

Diesel with up to 20 per cent biodiesel has been shown to have similar hazardous characteristics to straight diesel. Its impact on occupational and public health and safety should be no greater than diesel already supplied to the market.

(c) The interests of consumers


Fuel subject to the approval will be supplied to commercial customers only who will be advised in writing that the diesel contains biodiesel and that the density of the fuel may vary from the standard, enabling them to make informed choices especially concerning potential vehicle warranty issues.

(d) The impact on economic and regional development

The approval is expected to allow the development of new markets, where appropriate.

Summary of reasons for the approval

1. Biodiesel blends are already being supplied to the market and the approval is required to allow Caltex to continue supplying its blend to existing and potential customers.
2. It is not expected that significant environmental or consumer impacts will be caused by the use of the fuel subject to the approval.
3. The approval is likely to assist in the development of the biodiesel industry in Australia.
